

Privacy Policy Fundacji Na Nowo Polska

Introduction

Fundacja Na Nowo Polska (hereinafter referred to as the "Foundation") places great importance on respecting the privacy of its website users, beneficiaries, and partners. This Privacy Policy is intended to explain the principles of personal data processing by the Foundation, whether through its website or direct contact.

Personal Data Controller

The controller of your personal data is Fundacja Na Nowo Polska, headquartered in Warsaw at ul. Szczęsna 26, 02-454 Warsaw, registered in the National Court Register under number 0000952452. Scope and Purposes of Personal Data Processing

The Foundation processes personal data for the following purposes:

Statutory Activities – implementing social projects and providing support to individuals in difficult life situations.

Contact and Inquiry Management – processing contact data, including email addresses and phone numbers, to respond to inquiries and invitations for collaboration.

Compliance with Legal Obligations – fulfilling statutory duties, including accounting requirements.

Analysis and Statistics – analyzing website traffic and processing information related to site usage to improve and tailor it to user expectations.

Types of Processed Personal Data

The Foundation may process the following personal data:

Identification Data: name, surname, and PESEL (if required for a specific purpose).

Contact Data: email address, phone number, residential address.

Data Related to Foundation Activities: information about projects in which a person participates.

Automatically Collected Data: IP address, device and browser data, "cookies" (details below in section 6).

Sources of Personal Data

The Foundation collects personal data directly from the individuals concerned and through forms available on the website, including registration, contact, and project application forms.

Cookies and Other Tracking Technologies

The Foundation uses cookies stored on users' devices to tailor the content of its website to their preferences. Cookies allow us to:

Customize the content of the website to users' individual needs.

Simplify navigation and use of the site.

Conduct statistical analysis of site traffic to optimize it.

Types of cookies used:

Session Cookies – active only during the user's session.

Persistent Cookies – stored for a longer period, used to remember preferences.

Users have the option to disable cookies in their browser settings.

Disclosure of Personal Data

The Foundation does not disclose personal data to third parties unless required by law or necessary to fulfill specific tasks (e.g., collaboration with partners in project implementation). Data recipients may include service providers to the Foundation, who are obliged to adhere to data protection standards.

Rights of Data Subjects

Individuals whose data are processed by the Foundation have the right to:

Access their personal data and receive a copy.

Request rectification of inaccurate data.

Object to data processing.

Request data deletion ("right to be forgotten") in cases provided by law.

Restrict data processing.

Transfer data to another data controller.

Retention of Personal Data

Personal data will be retained by the Foundation for the period necessary to accomplish a specific task or until the consent is withdrawn by the data subject, unless a longer retention period is required by law.

Personal Data Security

The Foundation implements technical and organizational measures to ensure the security of processed personal data. Steps are taken to protect data against unauthorized access, loss, or destruction, in compliance with GDPR.

Changes to the Privacy Policy

The Foundation reserves the right to make changes to this Privacy Policy. Any changes will be published on the Foundation's website to ensure that interested parties have access to current information.
